Biography: Qianfan Zhang is the leading constitutional scholar and public intellectual in China, and has been the Vice President of the Chinese Constitutional Law Association since 2004. He obtained his Ph.D. in Government from University of Texas at Austin (1999), and taught comparative constitutional law and administrative law at School of Law, Nanjing University, where he served as the Chief Editor of the faculty law journal, Nanjing University Law Review. He joined the law faculty in Peking University in 2003, where he is now the director of the Center for the People's Congress and Parliamentary Studies and the senior deputy director of the Constitutional and Administrative Law Center. He has published widely in the areas of Chinese and comparative constitutional law, moral and political philosophy.
